1. TERMS

2. PRICES

Prices charged are in accordance with the latest Price List and are subject to change without notice. Goods supplied will be invoiced at the prices ruling at the time of delivery.

3. CLAIMS

Claims for damage or shortage will not be accepted unless notice thereof in writing is received within 7 (seven) days of dispatch of the goods.

4. OWNERSHIP

Ownership in goods sold shall remain vested in BISON MINING SUPPLIES PTY LTD (the Supplier until payment of the full purchase price has been made. The risk in the goods sold will pass to the Purchaser, immediately after delivery has been affected.

5. RETURNS

- 5.1 Generally, it is not our practice to accept returns where items have been correctly supplied against customer's orders.
- 5.2 Items will be accepted for return by prior arrangement only, and the items returned may be in a NEW SALEABLE condition and in the original packaging as supplied.

- 5.5 Items returned will be accepted on an exchange/replacement basis only.

6. JURISDICTION
